

COMMONS REGISTRATION ACT 1965

Reference Nos. 25/D/112 to 125 inclusive

In the Matter of Low Common, Thornham, West Norfolk District, Norfolk

DECISION

The 14 disputes relate to the registrations at Entry No. 1 in the said Land Section, at Entry Nos. 1 to 118 inclusive (Entry No. 115 has been replaced by Entry No. 119 in the Rights Section) and at Entry Nos. 1 and 2 in the Ownership Section of Register Unit No. CL 56 in the Register of Common Land maintained by the Norfolk County Council and are occasioned by Objection Nos. 273B and 274B made by Mr John Osborne-Clarke and noted in the Register on 16 October 1970, by Objections Nos. 169B, 170B, 171B, 172B, 173B and Nos. 295B and 304B made by Mr Henry Bourdillon Imlach Bett and noted in the Register on 16 and 27 October 1970 and by the said two Ownership Section registrations being in conflict.

Mr Commons Commissioner C A Settle QC held a hearing for the purpose of inquiring into these disputes at Mouth on 27 October 1977. At the hearing Mr H B I Betts (the said Objector and also the applicant for the Ownership Section registration Entry No. 2) was represented by Mr P R Fitzgerald, solicitor of Walters Vandercom & Hart Solicitors of London; Thornham Parish Council (the applicants for the registrations at Entry No. 119 in the Rights Section and at Entry No. 1 in the Ownership Section) were represented by Miss S Cameron of counsel instructed by Metcalfe Copeman & Pettefar, Solicitors of Wisbech; and some or all of the persons hereinafter called the Represented Claimants were also represented by Miss Cameron similarly instructed.

At the said hearing Mr Settle was informed that in the matter of Thornham Common (Reference Nos. 25/D/79-95) relating to the land ("the CL 41 Land") comprised in Register Unit No. CL 41 which is near to or adjoining land ("the Unit Land") in this Register Unit, I had given two decisions (one dated 18 December 1975 and corrected on 4 January 1976, and the other dated 17 June 1976 and corrected on 23 September 1976) which dealt with questions similar to those arising in these proceedings relating to the Unit Land. Miss Cameron and Mr Fitzgerald suggesting that it might be more convenient if I dealt with the proceedings, Mr Settle without hearing any evidence or argument adjourned them so that this suggestion could be considered.

I held the adjourned hearing for the purpose of inquiring into these disputes at London on 19 July 1979. At this hearing Mr Fitzgerald (now of Walters Fladgate, Solicitors of London) represented Mr Betts as before, and Miss Cameron on the instructions of Metcalfe Copeman & Pettefar represented Thornham Parish Council and the following persons ("the Represented Claimants"), that is to say: (a) the persons who made application for the Rights Section registration referred to in the Schedule hereto and who are not in such Schedule noted as not being represented;

and (b) the persons who although not the applicants for a registration so referred to have or might claim benefit of some registration therein mentioned either as a successor in title of an applicant or as the owner of the land to which the right register might be appurtenant or otherwise and who are noted in the schedule as being represented.

The Unit Land comprises saltings north and northwest of the CL 41 Land and is between it and the sea. In accordance with the colouring of a map produced at the hearing, I consider the Unit Land as divided into two parts: one ("the Brown Part") west of the Harbour Channel (as such marked on the Register map), being a strip about one mile long from east to west and having (according to the map) a variable width of between 400 and 100 yards and including a small island; the other ("the Purple Part") sest of the Harbour Channel being an irregularly shaped area about ½ a mile from north to south and between ½ and ⅓ of a mile from west to east and including 5 small islands. The Unit Land on its sea side is bounded by the High Water Mark of Medium Tides.

On 22 March 1974, I walked over much of the CL 41 Land, and I remember the general appearance of the Unit Land. I therefore accept the suggestion made by Miss Cameron and Mr Fitzgerald that I should treat all the evidence given at the 1974 and 1975 CL 41 hearings as having been given in these proceedings. This decision should therefore be read with Mysaid 1975 and 1976 decisions and expressions varied therein defined area herein given the same meaning.

Miss Cameron and Mr Fitzgerald were agreed that I should dispose of this matter (at least as far as concerned those they represented) on the same basis as I in my 1975 and 1976 decisions disposed of the matter of the CL 41 Land with the following variations: Of the Unit Land the Brown Part only would be subject to the rights of feeding and depasturing cattle as awarded and established by the 1797 Award, and would therefore be the only part of the Unit Land about which I should conclude that the ownership of the Public Trustee had been established for the reason set out in my 1974 decision. The small island shown as part of the Unit Land on the Register map and as being in the middle of the harbour "Harbour Channel" and as southeast of the letter "L" of the word "Channel" to be treated as within the Brown Part. The whole of the Unit Land will be subject to Samphire Rights with the result that it is all common land within the 1965 Act of these words. The Purple Part will be in the ownership of Mr Bett in accordance with Ownership Section Entry No. 2.

Hiss Cameron handed in a paper (18 pages of foolscap) which set out in detail how the agreement reached would operate on the registrations in dispute. The basic principles set out in this paper were (in effect):— the Land Section Entry will be confirmed without modification. The Samphire Rights referred to in the Schedule would be modified: (a) by deletion in each case of the words in column 4 "and in register unit CL 41, CL 122 and that part of register unit CL 32 north of the line A-B on the register map"; (b) by deletion in respect of each entry where the words appear in column 4 of the words "sand and shingle"; (c) by the addition in each case where the words "wildfowl and game" appear in column 4 of the words "excluding the western parts of the registered land as shown hatched purple on the supplemental map bearing the number of this registration" and (d) by the insertion in each case where the address does not already appear under column 5 of the address set out in column 3 (or as mainly a faces of the column 5 of the address set out in

As regards grazing rights the registrations against the CL 41 land and against the Unit Land are different in the following respect. Against the CL 41 land there are 4 registrations made on the application of Mr H H Middleton (Entry No. 113), of Mr Bett (Entry No. 120), of Miss J, Miss A M and Miss M E Bunkle (Entry No. 122) and of Thornham Parish Council (Entry No. 123); in my decision I treated these rights as equivalent to 1 stint, 46 stints, 1 stint and 1 stint making up the 49 stints established by the 1797 Award. Against the Unit Land there are two registrations made on the application of Mr H H Middleton (Entry No. 113) and of Thornham Parish Council (Entry No. 119); there are no registrations made on the application of Mr Bett or of the Misses Bunkle.

It may be that by reason of their failure to register under the 1965 Act Mr Bett and the Misses Bunkle can no longer exercise any rights of common they had over the Brown Part. However this may be, such failure cannot in my opinion affect the ownership of the Brown Part which (as I have found) was before the Act vested in the Public Trustee. Because there was no agreement about it and because I have no need, I express no opinion about the question briefly discussed at the hearing: whether Mr Bett or Misses Bunkle as beneficiaries under the trust applicable to the Brown Part can put animals on to it. If this question ever arises, it will have to be determined by the High Court or some other tribunal; having seen the Brown Part, it is I suppose unlikely that it will ever be worth so litigating.

At the hearing and evidence was given by Mr H H Middleton on whose application the registration at Rights Section Entry Mo. 113 was made, who is a member of the West Norfolk District Council and the present chairman of Thornham Parish Council. He explained what he and Mr Mitchell of Metcalfe Copeman & Pettefar done to obtain the view of those in Thornham might be concerned or interested to support the registrations now under consideration and for this purpose produced a copy of a public notice dated 18 June 1979 saying that Mr Mitchell would be available on 22 June 1979 in Thornham to ensure that they were represented at the hearing on 18 July 1979, a copy of the authority signed by various persons referring on the Parish Council or their solicitor right of representation at such hearing and a table (17 pages) brief showing who were or might be now concerned with the registration.

In the absence of Mr J Osborne-Clarke or of any person representing him and of any information as to why he made his objections, I conclude that I ought not to give them any greater effect than has been agreed between those represented by Miss Cameron and Mr Fitzgerald. As regards those persons I conclude (as I did in my 1976 decision) that I can and ought to give effect to the agreement reached between Miss Cameron and Mr Fitzgerald as regards the Right Section registrations referred to in the Schedule hereto. As regards the remaining Right Section registrations I conclude that I cannot and ought not to confirm these registrations cause I have not got the agreement of those entitled to the benefit of such registrations any modification and I have no evidence supporting the rights as now registered on their application. If there had been only one registration criginally in the Ownership Section, it would have become final under section 7 of the 1965 Act without any hearing before a Commons Commissioner; upon the considerations set out



In my 1974 decision and above, I conclude that I can properly act on the agreement of Miss Cameron and Mr Fitzgerald, for the two now existing Ownership Section registrations substituting as they suggest registrations of the Public Trustee as owner of the Brown Part and Mr Bett as owner of the Purple Part.

Section without any modification. Because so much of this decision depends on the agreement made as above stated between Miss Cameron and Mr Fitzgerald on behalf of those they represent, and because I may not have provided for all matters as requisite, I give to such persons liberty to apply to me within 6 weeks from the date on which notice of this decision is sent to them as to the form which the register should take as a result of the views I have above expressed and generally. Any such application should in the first instance be made by letter to the Clerk of the Commons Commissioners.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court. the application or make representation against it.


