In the Matter of Land near Bwlch-y-Groes, Llantysilio, Glyndwr D

## DECISION

I held a hearing for the purpose of inquiring into the dispute at Llangollen on 30 & 31 March and 1 April 1976. The hearing was attended by Mr Blackburn, counsel, instructed by Messrs Iliffes on behalf of Mr Wilson Evans and Pine View Developments Ltd, Mr Wynn Jones, counsel, instructed by Messrs Villiam Jones and Talog Davies on behalf of the successors to Emlyn Evans, Mr Richards on behalf of Mr T R Davies.

This Unit comprises 1.8 acres and adjoins Unit No. CL. 132. Both Hr Emlyn Evans and Mr T R Davies claim to graze their respective flocks over this Unit and Unit CL. 132 and are content that I shall modify the Entry No. 1 in the Land Section of Unit No. CL. 132 by adding thereto the land comprised in this Unit No. CL. 244 and refuse to confirm the Entry in the Land Section of this Unit, their rights over Unit CL. 132 being admitted.

For this reason I refuse to confirm the registrations.

I am required by regulation 30(1) of the Commons Commissioners legulations 1971 to explain that a person aggrieved by this decision as being erroneous in voint of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
