

COMMONS REGISTRATION ACT 1965

Reference N os. 51/D/170 and 171

In the Matter of Part of Llantysilio Mountain, Llantysilio & Bryneglwys, Glyndwr D

DECISION

These disputes relate to the registration at Entry Nos. 1 to 17 inclusive in the Rights Section of Register Unit No. CL. 128 in the Register of Common Land maintained by the former Denbighshire County Council and are occasioned by Objection No. 48 made by Duncan Robertson and noted in the Register on 23 September 1970 and Objection No. 116 made by C S Bond noted in the Register on 4 May 1972.

I held a hearing for the purpose of inquiring into the dispute at Llangollen on 1 April 1976. The hearing was attended by Mr Sopwith on behalf of Mr Duncan Robertson. Mr Parry counsel instructed by Messrs Hopley Pierce & Bird appeared for Mr Bird Jones and all the other applicants for rights appeared by their legal representatives or agents or in person. For the reasons given in my decision on References relating to CL. 128 I refuse to confirm Entry No. 16 made by Mr Bird Jones. It was agreed by all the interested parties that I should confirm Entry Nos. 1 to 9 inclusive and Entry Nos. 11 to 15 inclusive and Entry No. 17, Entry Nos. 9, 11, 13 and 14 being modified as follows:-

- Entry No. 9 by inserting after the words "comprised in this Register Unit" in column 4 the words "and Unit No. CL. 21 but so that the number of sheep grazed on this Unit and CL. 21 at any one time shall not exceed 94 ewes and 92 yearlings"
- Entry No. 11 by deleting all the words in column 4 and inserting in lieu thereof the following words viz "the right to graze 600 ewes and 500 lambs over this Unit and Units No. CL. 22 and CL. 123 but so that the number of sheep grazed at any one time over this Unit and CL. 22 and CL. 123 shall not exceed 600 ewes and 500 lambs"
- Entry No. 13 by deleting all the words in column 4 and inserting in lieu thereof the following words viz:- "The right to graze 294 ewes and followers over this Unit and Units Nos. CL. 22, CL. 126, CL. 127 and CL. 213 but so that the number of sheep grazed at any one time over this Unit and all the other said Units shall not exceed 294 ewes and followers"
- Entry No. 14 by inserting after the words "comprised in this Register Unit" the words 'and Units Nos. CL. 21, CL. 22, CL. 122 and CL. 123 but so that the number of sheep grazed at any one time cer this Unit and all the other said Units shall not exceed 400 sheep and 400 lambs" and it was agreed that I should refuse to confirm Entry No 10.



I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as being erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him, require me to state a case for the decision of the High Court.
