In the Matter of Ruabon Mountain

DECISION

These disputes relate to the Registrations in the Rights Sections of the above mentioned Register Units in the Register of Common Land maintained by the former Denbighshire County Council and are occasioned by the objections set out in the First Schedule hereto under the respective Register Units to which they relate.

I held a hearing for the purpose of inquiring into these disputes at Llangollen on 6 7 8 December 1977.

The hearing was attended by Mr J I Williams of Messrs Longueville and Co., on behalf of Sir Watkin Williams Wynn and Mr D R Richards of Messrs. Charles Richards and Sons, Mr David Parry of Messrs. Bowen Jones and Parry, Mr J L Jones of Messrs. Stanley Williams and Co. Mr Thomas of Messrs. W H Edwards and Co, Mr Wyn Jones of Messrs. William Jones and Talog Davies, Mr Grey Lloyd and Mr Gwilyn Hughes on behalf of various claimants for common rights.

All the above mentioned Register Units are part of or contiguous to the Ruabon fountain and it is unfortunate that as the result of the method of registration imposed by the Commons Registration Act 1965 it has for the purpose of that Act been livided into several distinct units of common land. The fact is that on the ground there are no boundaries dividing one unit from another unit and therefore one farmers flock of sheep, do in fact graze two or more units. In these circumstances farmers have registered their flocks for rights on all the units in which they graze with the result that if their claims for rights were to be confirmed in each unit there would be duplication. If each unit were to be dealt with in isolation and the Rights claimed were to be confirmed there would be 44.000 sheep grazing on the mountain.

ir Leathes the Land Agent for the Wynstay Estate gave expert evidence that for a period of eleven years he had been familiar with the mountain which covers an area of 7000 acres and that he had experience of other similar mountains. He said it was not a good mountain and that it could carry only one sheep to the acre and that 12 sheep to the acre was the maximum.

He was cross-examined by Mr D R Richards, Mr David Parry, Mr J L Jones, Mr Thomas and Mr Wyn Jones, They had all reached agreement with Mr J I Williams as to the size of the flocks, their respective clients were to be entitled to graze on the mountain provided that other applicants for rights reached similar agreements or were dealt with in the like manner. It was anticipated that the end result would be that the total number of sheep grazing on the mountain would be approximately 10.000 which would be consistent with the maximum of $1\frac{1}{2}$ sheep to the acre the maximum for which Mr Leathes contended.

The provisional agreements referred to above were arrived at at a meeting which took place on the afternoon of 6 December 1977. The provisional agreements were as to the size of farmers' respective flocks on the footing that the Entries in the Rights Sections of the Register should be modified.

So as to provide for the agreed numbers and also so as to provide that not more than these mambers should be grazed on the mountain at any one time.

In these circumstances on 7 December I heard those who were not present at the said meeting who were then present or represented and in the course of hearing those present agreement was reached with all of them.

It remained for me to consider what course to take as regards those commoners who did not attend viz. Mr I O Eoberts (now deceased) and Messrs Lowe Allwood, Ellis Jones W H Price Weaver, Denbighshire County Council, D S Ellis, J L Hughes, Lightfoot and A Smith. I was invited to refuse to confirm all these registrations on the grounds that they had not appeared to support their claims. Since there were a large number of farmers present who I thought might have reliable information as to the grazing activities of the absentees and since any absentees who had a valid reason for not attending might invite me to reopen the hearing with the consequent waste of time and expense. I took the view that I should make every effort to conclude the matter at the hearing. Mr Williams agreed that I should take this course and in the event I am satisfied that this was the correct course since it emerged that several of the absentees were part time farmers and unable to attend by reason of their employment and Mr R H B Lewis told me that he and three of his neighbours had reached an agreement as to the sizes of their respective flocks which grazed on one area of the mountain.

I was told that Messrs. Ellis Jones and W H Price had no sheep and that no sheep had been grazed from the lands owned by W H Price and I therefore refuse to confirm his Entries. In the case of Mr Ellis Jones I was told that although he was not currently grazing, sheep had been grazed from his land and in the absence of any suggestion that he intended to abandon his rights I confirm his Entries as stated in the Second Schedule hereto.

As regards the grazing by the other absentees on the evidence given by their neighbours I confirm their Entries modified as stated in the Second Schedule and Mr Williams agreed that I should take that course.

It remains to deal with a submission by Mr Dodd, who claims to graze cattle as well as sheep. I was told that them was a "Sheep Mountain" and that theme were no rights to graze cattle. No other applicant for rights now claims to graze cattle.

Evidence was given that Mr Dodds predecessor in title had cattle on the mountain but the evidence was to the effect that she left her gate open and allowed the cattle to wander on the mountain but that they returned to the home farm at nights and relied for their feed on that provided at their home farm. In my view these cattle were not pure to graze on the mountain and their being allowed to wander there was not the exercise of a right but merely tolerated by the other interested parties. For these reasons I reject Mr Dodds claim to graze cattle.

As regards the Entries in the Rights Sections not specifically mentioned above I confirm these Entries where necessary modified as stated in the Second Schedule hereto.

What I have said above is a record of the proceedings at the hearing and deals with the provisional registrations which it falls to me either to refuse to confirm or to confirm with or without modification. I regret that at the hearing I did not observe that on many of the units with which I was concerned there are final registrations and my attention was not drawn to this circumstance. Many of these final registrations are a multiplicity of Entries for one flock but I have no power to modify those Entries. There are set out in the Third Schedule to this decision what I believe to be a list of the final registrations on the units with which I dealt at the hearing and there may be and probably are others on units which are part of Ruabon Mountain which did not come before me at the hearing.

I hoped that this decision which I believe accords with what was agreed by all those attending or represented at the hearing would resolve all the disputes referred to me on that it would establish a scale of grazing acceptable to all the commoners and the owners of the common. However, it may be that the final registrations and registrations on other units not before me at the hearing have the effect of undermining the foundation of this decision namely a scale acceptable to all those entitled to graze on the Ruabon Mountain. I have delayed giving this decision for a very long time in the hope that I might receive some suggestions as to how the problems arising out of the final registrations and Entries in other units might be solved. In the absence of any such suggestions I must assume either that such problems are of no great materiality or that they are insolvable. In these circumstances I have no alternative but to issue this decision which deals with all the disputes referred to me and to express the hope that if the Rights recorded in the Rights section of the Registers do not give effect to the scale of grazing envisaged by those who agreed to the modifications of their rights as provided for by this decision they will reach agreement with those who may have excessive rights as to the exercise of those rights.

I am required by regulation 30(1) of the Commons Commissioners Regulations 1971 to explain that a person aggrieved by this decision as bieng erroneous in point of law may, within 6 weeks from the date on which notice of the decision is sent to him require to to state a case for the decision of the High Court.
